


YCFCWCD Average Groundwater

Depth by Season (August 2021 is 117 wells)






Comparison with 2015 Drought





- Non-profit organization with 40 members
- Provides irrigation water to approximately 340 acres in northern Capay Valley
- RWUA requested YSGA membership and representation by farmer Ken Muller
- EC recommends 1-year backpay + current FY dues (\$340*\$0.50/acre*2 years = \$340)

Buckeye Creek Recharge Project

- 180-day temporary permit with SWB
- Diverts water from Tehama Colusa Canal to Buckeye Creek via dewatering gates
- Pilot project that can be applied to other small Creeks
- Estimated cost: \$60-123k
- Estimated AF recharged: 1-2 TAF
- Cost per AF: ~\$60/AF




